### ACADEMIC INCENTIVE FUNDING REGULATION

In accordance with the Presidential Decree No. 2043 dated 16/1/2020, published in the Official Gazette No. 31011 dated 17/1/2020, this Regulation has been added to the Presidential Regulation section.

#### Purpose and scope

ARTICLE 1 - (1) The purpose of this Regulation is to determine the detailed characteristics of the activities to be taken as basis in calculating academic incentive points according to the characteristics of the scientific fields and the titles of the academic staff, the score equivalents of these activities, the weights of each type of academic activity in calculating the total score, not to exceed 30% of the total academic incentive score, the procedures and principles regarding the calculation of the academic incentive score, the formation of the commission that will make these calculations and other issues, with a view to the implementation of the academic incentive allowance to be made to the academic staff in the state higher education institutions.

(2) The provisions of this Regulation also apply to the academic staff of the National Defense University, the Gendarmerie and Coast Guard Academy and the Police Academy.

#### Rest

**ARTICLE 2** - (1) This Regulation has been prepared based on the additional article 4 of the Higher Education Personnel Law No. 2914 dated 11/10/1983.

#### **Definitions and abbreviations**

**ARTICLE 3** - (1) In the implementation of this Regulation;

- a) AHCI: Art and Humanities Index,
- b) Field indices: Indices accepted for associate professorship applications prepared by the Interuniversity Board and approved by the Council of Higher Education,
  - c) Citation: Quoting a work from another work,
- $\varsigma$ ) The highest civil servant gross salary: The amount found by multiplying the indicator figure (9,500) [monthly indicator figure (1,500) + additional indicator figure (8,000)] by the civil servant monthly coefficient,
- d) Activities: References to projects, research, publications, designs, exhibitions, patents and studies that have been completed domestically or abroad in the previous year that contribute to science, technology and art, papers presented at international meetings with a scientific committee and academic awards received for each calendar year,
  - e) Commission: Academic incentive regulation, auditing and objection commission,
  - f) Awards: Awards received by the applicant for professional, scientific or artistic activities related to his/her field,
- g) Project: The entirety of activities carried out within the framework of scientific principles and whose purpose, scope, general and technical definition, duration, budget, special conditions, amounts of in-kind and/or cash support to be provided by other institutions, organizations, real and legal persons, and the principles of sharing the resulting intellectual property rights have been determined and will determine every phase of R&D activities.
  - g) SCI: Science Citation Index,
  - h) SCI-Expanded: Science Citation Index-Expanded,
  - i) Exhibition: Exhibitions, biennials, triennials, shows, concerts, festivals or screening events of an artistic nature,
  - i) SSCI: Social Sciences Citation Index,
  - j) Calendar year: The period between January 1 and December 31,
- k) (**Definition:** Well-known national publishing house: A publishing house that has been operating regularly at the national level for at least five years and has previously published at least twenty books by different authors in the same field. (The phrase was annulled by the decision of the Eighth Chamber of the Council of State dated 14/6/2022 and numbered E.:2018/4831; K.:2022/4095; the aforementioned decision became final with the approval decision of the Council of State IDDK dated 5/4/2023 and numbered E.:2022/3741, K.:2023/650.)
- l) Well-known international publishing house: A publishing house that has been operating regularly at the international level for at least five years, has published at least twenty books by different authors in the same field in languages other than Turkish and (The phrase was annulled by the decision of the Eighth Chamber of the Council of State dated 14/6/2022 and numbered E.:2018/4831, K.:2022/4095; the decision became final with the approval decision of the Council of State

### **IDDK** dated 5/4/2023 and numbered E.:2022/3741, K.:2023/650.)

- m) (Amended:OG-17/1/2020-31011-CK-2043/1 art.) Design: The original first drawing or original design of a structure, product or object,
  - n) Paper: Paper presented orally and published in a refereed international scientific conference, symposium or congress ,

- o) National patent: Patent applied for within the scope of national legislation and granted by the Turkish Patent and Trademark Office as a result of the examination report,
- ö) International patent: An international patent application made within the scope of the Patent Cooperation Treaty and in which it is stated in the written opinion section of the international search report or in the international preliminary examination report that at least one claim meets the patentability criteria (novelty, inventive step, industrial applicability) or a patent applied for within the scope of the European Patent Convention and granted by the European Patent Office,

- r) Publication: A review, article or short article (letter to the editor, commentary, case report, technical note, research note, abstract and book review) published in journals, a book or book chapter, editorship and editorial board membership and audio

- §) (Added: RG-17/1/2020-31011-CK-2043/1 art.) Research: Provided that it is not within the scope of the project article; systematic studies that are carried out in accordance with scientific principles in order to produce new information, solve/analyze technological problems, develop innovative products, processes, works or designs in Turkey or abroad for at least four months with an assignment from outside the institution, and whose final report is deemed successful by the competent authorities of the relevant institutions,

### Academic incentive regulation, monitoring and objection committee

- ARTICLE 4 (1) In order to fulfill the duties assigned to it in this Regulation, an academic incentive regulation, monitoring and objection commission is established consisting of members elected by the senate from among three candidates to be proposed by the rector for each membership, at least one person from each associate professorship basic field among faculty members with high academic incentive scores within higher education institutions. The chairmanship of the commission is carried out by the vice-rector assigned by the rector. The commission is elected for a period of two years, provided that it consists of at least four members, excluding the chairman. The member whose term has expired may be reelected. In the event of a vacancy in the membership for any reason, a new member is elected in the same manner to complete the remaining term.
- (2) The commission meets with the absolute majority of the total number of members, including the chairman, and takes decisions with the absolute majority of those attending the meeting. In the event of a tie, the decision is deemed to have been taken in favour of the vote of the commission chairman. Members cannot abstain from voting.
- (3) The Commission is responsible for determining and announcing the application procedures and principles before the applications begin, preparing and executing the academic incentive application calendar, and completing the process by February 15 of the year in which payment will be made.
- (4) The Commission is the final decision-making authority in resolving any doubts regarding the documentation of activities and their classification into activity types.

### Unit academic incentive application and review committee

- **ARTICLE 5** (1) In order to fulfill the duties assigned to it in this Regulation, a unit academic incentive application and examination commission consisting of at least three members is established within each department, major branch or art branch headship of higher education institutions. The unit academic incentive application and examination commission headship is carried out by the relevant department, major branch or art branch headship. The members of the unit academic incentive application and examination commission are selected from among the faculty members with high academic incentive scores by the relevant unit's Board of Directors. In the event that there are not enough faculty members within the department, major branch or art branch headsships, the members are completed with faculty members from similar fields. The members of the unit academic incentive application and examination commission are elected for a period of two years. The member whose term has expired may be re-elected. In the event that the membership becomes vacant for any reason, a new member is elected in the same manner to complete the remaining term.
- (2) The unit academic incentive application and review committee meets with the absolute majority of the total number of members, including the chair, and takes decisions with the absolute majority of those attending the meeting. In the event of a tie, the decision is deemed to have been taken in favor of the vote of the chair. Members cannot abstain from voting.
- (3) The unit academic incentive application and review committee is responsible for the evaluation of activities in accordance with the provisions of this Regulation and is authorized to resolve any hesitations that arise in the documentation of
- (4) (Added: RG-17/1/2020-31011-CK-2043/2 art.) If there are sufficient teaching staff, the members of the unit academic incentive application and review commission cannot be appointed as members of the academic incentive regulation, audit and objection commission at the same time.

#### Academic incentive application and evaluation process

activities and their classification within activity types.

**ARTICLE 6** - (1) Academic staff shall submit their academic incentive applications to the relevant unit academic incentive application and review committee of the higher education institution where they hold positions, together with the printout from YÖKSİS, in accordance with the announced procedure, together with samples, evidence and documents related to their academic activities. The unit academic incentive application and review committee may request additional explanations, information and documents from the applicants regarding their academic activities, if deemed necessary, at all

stages of the evaluations. Applicants are obliged to fulfill such requests. Applications made by academic staff are reviewed by the unit academic incentive application and review committee.

- (2) In case of a change of higher education institution, the YÖKSİS output shows in which institution each activity is carried out and the evaluation of academic activities carried out in different institutions is made in the higher education institution where the academic staff is located.
- (3) Applicants are required to apply to the unit academic incentive application and review committee appropriate to their activities in their fields. The unit academic incentive application and review committee first decides whether the applicant's activities are suitable for review. Applications that are not deemed suitable are forwarded to the committee for evaluation with justification.
- (4) The unit academic incentive application and review committee examines the applications and sends the decision report, the evaluation report regarding the applications and the score table in its annex, signed and approved by the department head in departments affiliated to the rectorate, the dean in faculties and the director in other units, in accordance with the announced calendar to the committee. It is mandatory to make a statement regarding the academic activities that are rejected or whose score values are changed in the evaluation report prepared by the unit academic incentive application and review committee.
- (5) The Commission examines the applications and evaluation decisions sent by the unit academic incentive application and review commission. If deemed necessary, it may request additional documents and information from the applicants and/or make changes to the decisions received from the units. The Commission signs the decision report it prepares, the evaluation report regarding the applications and the score table in its appendix, and announces its final decisions to the relevant researchers in writing or electronically. It is mandatory to make a statement regarding the academic activities that are rejected or whose score values are changed in the evaluation report prepared by the Commission.
- (6) Objections to the Commission's decisions may be made in writing within five working days from the date of announcement. The Commission will decide on the objections within five working days from the date the objection period ends. The Commission's decisions are final.
- (7) The activities of the teaching staff assigned from state higher education institutions to foundation higher education institutions during the assignment period are not taken into account in the calculation of academic incentive points. In the calculation of the academic incentive points of the teaching staff transferred from foundation higher education institutions or another institution to the positions in state higher education institutions, only the activities they have performed in state higher education institutions are taken into account.
- (8) Academic staff who are outside the institution due to assignment apply to units suitable for their expertise in the institutions where they are employed.
  - (9) Foreign academic staff cannot benefit from academic incentive allowance.

### Evaluation of academic incentive activity areas

ARTICLE 7 - (1) Only activities related to the applicants' own field are considered within the scope of academic incentive.

- (2) In the evaluation of project activities, only projects that contribute to science, technology and art and have been successfully completed at home or abroad and whose final report has been approved are taken into consideration. In order for externally funded (domestic or international) projects carried out through revolving funds to be evaluated within this scope, the project must have an R&D nature and the total project duration must not be less than nine months. Only academic supports of the Scientific and Technological Research Council of Turkey are taken into consideration within this scope, however, industrial, public, entrepreneurship, scientific activity and science and society supports are not taken into consideration. Projects aimed at establishing research infrastructure, entrepreneurship, supporting the research culture of researchers and students, scientific research projects supported by higher education institutions, supports of the Turkish Employment Agency, Small and Medium Enterprises Development and Support Administration, development agencies and similar institutions that provide funds for local development, community service, vocational training, social responsibility and similar purposes, expertise and consultancy provided through revolving funds, European Union Pre-Accession Financial Assistance projects are not taken into consideration. Duplicate scoring is not done for studies that are intended to provide complementary or supportive budget support for an implemented project by different institutions or organizations and are essentially part or extension of the same project.
- (3) In the evaluation of research activities, only research that contributes to science, technology and art, that has been successfully conducted domestically or abroad with the permission of the board of directors of the higher education institution and has been assigned outside the institution and whose final report has been found successful by the competent authorities of the relevant institutions, will be evaluated. The permission of the board of directors of the higher education institution must be attached to the application. Research is evaluated on a monthly basis. Action plans, feasibility reports and inventory studies and research that last less than two months will not be evaluated.
- (4) (Amended: RG-17/1/2020-31011-CK-2043/3 art.) It is essential that books have ISBN numbers and journals have ISSN numbers. Authorship of books, chapter authorship in books and book editorship should be documented with documents such as a contract with the publishing house, an invitation letter from the publishing house or the editor. Congress, symposium, conference or similar scientific event booklets and published papers in their content are not evaluated in the publication category. Curatorship books prepared within the scope of exhibitions, books consisting of papers presented at a congress and question books prepared for exams are not evaluated. In the evaluations related to books, the year of publication of the book is essential. In this context, a new edition of a previously evaluated book or book chapter is not evaluated. In the evaluation of articles published in journals, it is essential that the relevant journal is printed or published electronically (volume, page and

year information and imprint should be clearly presented). In order for other internationally refereed journals to be included in the evaluation, they must have been published with at least one issue per year for at least five years, the journal's editor or editorial board must be international, the scientific evaluation process and how this process works must be available on the journal's website, and the identities of published articles must be accessible through the journal's website. In the evaluation of editorships in journals, only one editorship is taken into account, even if it is in different journals. In journals with multiple editors, only the editor-in-chief is evaluated within the scope of incentives. In the evaluation of performance-based sound and/or video recordings on a national and international scale, the condition of being published is sought.

- (5) In the evaluation of design activities, only designs that contribute to science, technology and art, are related to the applicant's own field and are implemented or commercialized pursuant to a contract with public institutions or private legal entities are taken into account.
- (6) In the evaluation of exhibition activities, those that contribute to art are taken into consideration. In order for an exhibition to be evaluated internationally, the international nature of the exhibition must be approved by the department, major or major art branch boards. For repetitive activities, a maximum of two activities are taken into account and the second repetitive activity is given half the score of the previous one. In the evaluation of activities within the scope of the exhibition, exhibitions within the scope of education-training activities and student club activities are not taken into consideration.
  - (7) Patents without national examination are excluded from the scope of evaluation.
- (8) In the evaluation of citations, only publications or works evaluated within the scope of this Regulation and references to publications or works evaluated within the scope of this Regulation are taken into account, others are excluded from the scope. References made by the applicant to his/her own publications or works are excluded from the scope. References made by the applicant to publications or works produced only in state higher education institutions are valid, others are excluded from the scope. The number of people is not taken into account in the evaluation of citations, and separate scores are given for each applicant. References made to the same publication or work in different sections or parts of a book or article are considered as only one citation. However, in books with different section authors, separate scores are given for each citation made in different sections.
- (9) (Amended: RG-17/1/2020-31011-CK-2043/3 art.) In order for an event in Turkey or abroad where the papers are presented to be considered international, it is essential that there are speakers from at least five different countries other than Turkey presenting oral papers and that more than half of the papers are presented by participants from outside Turkey. In addition, there must be a decision by the university board of directors regarding whether the event is international, which will form the basis for payment. In the evaluation of the papers, it is essential that the paper is presented at the relevant event and that this is documented (event program and document showing that at least one researcher whose name is included in the paper participated in the event). In addition, for the evaluation, the paper must be included in the event paper booklet in electronic or printed form and its published full text must be submitted.
- (10) In evaluating the awards, it is essential that the award is given for the work done by the applicant in his/her field. Awards given for papers, awards given by publishing houses or journals for journal refereeing, and awards received by the applicant from his/her university are not taken into consideration.
- (11) In the evaluation of awards, the date on which the award was received is taken as basis; in the evaluation of projects and research, the date on which the projects and research were concluded is taken as basis; in the evaluation of designs, the date on which the design was concluded is taken as basis; in the evaluation of patents, the date on which the patent was registered is taken as basis; and in the evaluation of exhibitions, the date on which the exhibition was opened is taken as basis.

#### Calculation of academic incentive allowance

- **ARTICLE 8** (1) Academic incentive payment is calculated by dividing the highest civil servant gross monthly salary amount by 100% for those in professor positions, 90% for those in assistant professor positions, 70% for those in research assistant and lecturer positions, and the academic incentive score is applied as a ratio [Academic incentive payment amount = highest civil servant gross monthly salary x rate determined according to academic staff titles x (academic incentive score/100)].
- (2) Academic incentive points are calculated as follows, based on the Activity Calculation Table in the annex of this Regulation (Table 4).
- a) First, the score for each type of academic activity is calculated. This calculation is obtained by multiplying the sum of the rates that the academic staff has received due to the activities defined for each type of activity by the score determined for each type of academic activity [Academic activity type score = sum of activity rates x score determined for the academic activity type].
- b) The academic incentive score, which forms the basis for academic incentive payment, is calculated by adding the points obtained from each type of academic activity.
- (3) The activity points collected by the faculty member from each activity type cannot exceed the points determined for the academic activity type, and the academic incentive points (total activity points) cannot exceed one hundred points.
- (4) When determining the rates for multi-title publications (article, compilation, book or book chapter), notifications and patents, the coefficient (k) in the table below, which takes different values depending on the number of people in the activity, is taken as basis (Table 1).

(5) For projects that can be evaluated within the scope of academic incentives, the applicant's role in the project is determined based on the (r) coefficient in the table below (Table 2).

In calculating the academic incentive score for research articles and compilation articles (letter to the editor, comment, case report, technical note, research note and book review, provided that they are published independently) published in journals within the scope of SCI, SCI-Expanded, SSCI and AHCI, the (p) coefficient based on the latest Quarterly classification of the journal published by ISI Web of Science for the year the article was published and given in the table below is used. However, the relevant Q value of the journals included in the scope after the latest quarterly list is accepted, and the lowest coefficient value is applied for journals for which a Q value has not been determined. The coefficient value is applied as 0.5 for journals within the scope of AHCI. (Table 3).

- (7) For activities that do not have a specific sharing ratio or a name ranking or rating, the "ratio/number of people" ratio is taken into account. However, mixed events in the exhibition activity type and mixed audio and/or video recordings based on performances on an international scale are evaluated with full points regardless of the number of people.
- (8) In calculating the points and payments, the title of the academic staff on the date of the incentive application is taken as basis.

## National Defense University, Gendarmerie and Coast Guard Academy and Police Academy

**ARTICLE 9** - (1) The matters included in Articles 4, 5 and 6 for the academic staff working in the National Defense University, Gendarmerie and Coast Guard Academy and Police Academy are determined by the rectors or academy presidents, depending on their relevance.

#### Other provisions

ARTICLE 10 - (1) Applications cannot be made outside the fields of activity specified in this Regulation.

- (2) Academic incentive allowance;
- a) This is done as long as the teaching staff receive monthly payments in accordance with Law No. 2914 and Turkish Armed Forces Personnel Law No. 926 dated 27/7/1967.
- b) It is paid on the fifteenth of each month for twelve months, starting from the fifteenth of February, based on the academic incentive points calculated for each calendar year based on the activities carried out in the previous year.
- c) It is not subject to any tax except stamp duty and is not taken into account in the calculation of any raises, compensations, allowances, revolving fund additional payments, bonuses, wages and similar payments made under any name whatsoever, in accordance with the relevant legislation.
  - (3) In order for the academic incentive allowance to be paid, the academic incentive score must be at least thirty.
- (4) While academic incentive payments continue, payments for those who change institutions are made by the new higher education institutions.
- (5) Payments made to those who are found to have applied for activities that are found to be untrue or not within the scope of this Regulation after the payment is made shall be taken back with legal interest. An investigation shall be initiated upon the determination and notification of the commission regarding those who have made untrue, false or misleading notifications. If penal sanctions are required to be applied according to the results of the investigation, general provisions shall be applied.

### Repealed legislation

**ARTICLE 11** - (1) The Academic Incentive Allowance Regulation, which was put into effect with the Council of Ministers Decision No. 2016/9714 dated 27/12/2016, has been abolished.

#### Force

**ARTICLE 12 -** (1) This Regulation, prepared by taking the opinion of the Court of Accounts, shall enter into force on the date of its publication.

### Executive

**ARTICLE 13** - (1) The President shall execute the provisions of this Regulation.

Article 7 of the Regulation on Amendments to the Regulation on Academic Incentive Allowance, which was put into effect with the Presidential Decree dated 16/1/2020 and numbered 2043, which includes the provision "This Regulation shall enter into force on the date of its publication." was annulled by the Decision of the Eighth Chamber of the Council of State dated 14/9/2022 and numbered E.:2020/730; K.:2022/4736 on the grounds of incomplete regulation that does not foresee a transitional provision for academic studies in 2019, and the aforementioned decision became final with the Approval Decision of the Council of State IDDK dated 5/2/2024 and numbered E:2023/963 K:2024/185. With the aforementioned framework regulation, articles 3, 5, 7, 8 and 13 of this Regulation and table 4 were amended.

With the first article of the Presidential Decree numbered 2043, published in the Official Gazette dated 17/1/2020 and numbered 31011, the phrase "in languages other than Turkish" was added after the phrase "regularly operating" in subparagraph (l), the phrase "TÜBİTAK" was added before the phrase "National Academic Network" in subparagraph (p), and the phrase "published" in subparagraph (r) was changed to "published".

With the 2nd article of the Presidential Decree numbered 2043, published in the Official Gazette dated 17/1/2020 and numbered 31011, the phrase "responsible for the evaluation of the activities in accordance with the provisions of this Regulation" was added to this paragraph after the phrase "investigation committee".

With the 6th article of the Presidential Decree No. 2043, published in the Official Gazette dated 17/1/2020 and numbered 31011, the phrase "Council of Ministers" in this paragraph has been changed to "President".
